

## Notification of Changes Regarding BlackRock Money Market Funds as Sweep Options

As of July 8, 2016, the following BlackRock Money Market Funds (the “Funds”) will no longer be available for designation as an automatic or other cash sweep option in your Merrill Lynch account:

- BIF Tax-Exempt Fund
- BIF Government Securities Fund
- BBIF Government Securities Fund - Class 1, 2, 3 and 4
- BBIF Tax-Exempt Fund - Class 1, 2, 3 and 4
- State tax-exempt money market funds<sup>‡</sup>

Your account agreement will be amended accordingly.

You will be notified of additional instructions and information regarding this event if you already hold shares in one of the Funds.

If you subsequently choose one of the Funds as your cash sweep option after receipt of this Notification, your Fund balance will be liquidated and invested in the BIF Money Fund or BBIF Money Fund, depending on your account type, on or about July 8, 2016. The BIF Money Fund or BBIF Money Fund will then become your new automatic or other cash sweep option unless you contact Merrill Lynch and select a different cash sweep option. Please refer to your account agreement or contact Merrill Lynch with questions regarding your other cash sweep options.
